



2011 ANNUAL MSHA PART 46 REFRESHER TRAINING

***** Sponsored by the Washington Aggregates & Concrete Association
In cooperation with MSHA & Eastern Washington University FA**

Part 46 requires 8 hours of Annual Refresher training for “Experienced and Newly Hired Miners” as per MSHA regulations. The WACA Safety Committee offers affordable and comprehensive Aggregate industry specific training modules to help you satisfy these requirements.

This 1-day program is designed to bring you both Aggregate industry specific topics and / or Annual First Aid refresher hours (4) to satisfy the 8 hours of required training. Your existing safety plan should be modified to include the training elements presented when attending this program.

***** Part 46 Deadline for Annual Training is: within a 12 month period of previous training *****

2 elements of Safety training are offered:

- First Aid training:** 4 hour Refresher Training is offered in the AM (and PM if necessary) plus 4 hours of topical training will satisfy your ** 8 hour requirements.
- Topical Training:** Aggregate Industry Topics will satisfy your ** 8 hour requirements. Your safety plan must be modified to include program topics.

Our program includes: First Aid Training by Trent Hahn of EWU. Topical Training sessions presented by aggregate industry safety professionals, safety company representatives, and MSHA personnel. * Note: some topics subject to change as speaker schedules may change**

- Each Facility will be required to complete 30 minutes (or more) of safety training regarding specific changes to the mine site (MSHA required element). ***** This year, we are assigning the additional task (1 hour) of conducting safety audits at your facilities. Miners will need to conduct self audits on site, identify issues or areas needing correction, and should be discussed at safety meetings. *** Miners will leave these sessions with approx 6.5-7 hours of training.**
- Times shown are approximate session times. Program will start promptly at 8:15 AM. Break time will be provided for Lunch.
- Instructors are experienced Aggregate Industry Safety Managers, trained and qualified safety consultants, vendors, and NW regional MSHA personnel. First Aid Training may be either Medic One or National Safety Council Programs.
- Upon successful completion of First Aid Refresher Training and Topical Training, miners will receive Topical and First Aid certificate of completion for training completed. Copies should be retained in individual miner personnel training files and on site company safety plans.*

Program Fees:

First Aid / 4 hour Refresher training (Class size limited)	25.00 / person
Topical Session Training (½ or Full day)	28.00 / person for WACA members \$85.00 / person for <u>NON</u> WACA members.

(A miner may combine 4 hours of First Aid Refresher Training with 4 hours of Topical AM or PM Sessions)

Topics may vary per location and may be subject to change. If available, topic specific written materials will be handed out. A certificate of completion will be given upon successful completion of the 4 or 8 hour training. Coffee service will be provided in the AM. *Lunch is on your own.*
