A rate of \$115.00 per ready mix concrete truck will apply. Membership dues for this category should be calculated on the number of active, registered, or available trucks. Note: Additional Aggregate production schedules no longer apply to this category.

CATEGORY III - CEMENT COMPANIES

ANNUAL MEMBERSHIP RATE: \$2265

CATEGORY V - CAPITAL EQUIPMENT RELATED

ANNUAL MEMBERSHIP RATE: \$1080

Companies that distribute, manufacture, sell or service **CAPITAL** equipment including, but not limited to: batch plants, aggregate processing, trucks and related components, excavation or manufacturing equipment, environmental/recycling systems, and scales. Includes all batching, conveyor, screening, washing, crushing, and service and related parts for the above systems and equipment.

ANNUAL MEMBERSHIP RATE: \$720

ANNUAL MEMBERSHIP RATE: \$480

CATEGORY VIII - RETRO ASSOCIATE MEMBERS

ANNUAL MEMBERSHIP RATE: \$570
