PROGRAM OVERVIEW:

Concrete Flatwork Associate: ACI will grant certification to those candidates who obtain a passing grade on the written examination. The two-hour written examination is closed-book and consists of approximately 50 multiple-choice questions. The passing grade for the written examination is 70%.

Certification is valid for a period of five years from the date of successfully completing all requirements.

Individuals with Concrete Flatwork Associate certification can upgrade to Advanced Finisher status upon submittal and approval of sufficient work experience or combination of sufficient work experience and passing the ACI performance examination. Certification at the Advanced Finisher level is valid for the remainder of the original Associate certification period.

Recertification requires successful completion of a written examination OR 10 hours documented continuing education from an approved source.

Advanced Concrete Flatwork Finisher: ACI will grant certification to those candidates who obtain a passing grade on the written examination PLUS Possess 4,500 hours of actual on-the-job finishing* experience (approximately three years of regular full-time work) **Important Note:** *The option for submitting 1,500 hours of work experience and passing the performance exam is not available as we do not conduct performance exams. Please complete the work experience form to include 4,500+ hours.*

Certification is valid for a period of five years from the date of successfully completing all requirements.

Recertification requires successful completion of EITHER a written examination OR a combination of 10 hours documented continuing education from an approved source and 4500 hours of verified continuing work experience attained within the previous 5 years.

*Finishing experience includes concrete placement, consolidation, jointing, curing and protection, finishing, form setting, prep work, rubbing, patching, and saw cutting. Verification of the work experience by the candidate's employer(s) is required.
