Low Carbon Concrete - The proposed Code defines Low-Carbon Concrete (LCC) as concrete designed with reduced upfront embodied Global Warming Potential (GWP). The proposed Code is in addition to and does not substitute governing building or structural design codes and standards. The proposed Code focuses on the concrete component, i.e., the concrete mix designs and their associated volumes used on a project.

NRMCA - EPA GRANT

Presented by **Lionel Lemay**, Executive Vice President, Structures and Sustainability, National Ready Mixed Concrete Association (NRMCA)

Through a five-year project, the NRMCA aims to increase the quantity and quality of Environmental Product Declarations (EPDs) for ready-mix concrete. NRMCA plans to provide grants to producers to develop EPDs for an additional 3,000 plants, doubling the current 1,500. Through this initiative, NRMCA will collaborate with all stakeholders involved to ensure its success. NSSGA - Environmental Update

NSSGA will present information on upcoming rules and discuss environmental compliance and justice. The Environmental Protection Agency and the Army Corps of Engineers have introduced Regional Streamflow Duration Assessment Methods (Regional SDAMs) for use across the contiguous United States. These methods allow for quick field assessments to classify streamflow duration as perennial, intermittent, or ephemeral based on observable indicators during a single site visit.
